

## Preliminary capital gains distribution estimates

Mutual funds and ETFs typically distribute taxable capital gains to shareholders each December. Below is a list of Vanguard funds that were expected, as of October 31, 2023, to distribute taxable capital gains in December 2023.

To estimate the distribution for a fund on this list, multiply the fund's total per-share capital gains estimate by the number of shares your client owns.

These figures are only estimates. Actual year-end distributions may be higher or lower based on market volatility, portfolio and shareholder activity, and tax adjustments. On December 8, we plan to provide final estimates, including estimated income, for all funds. Final distribution amounts will be added to our fund-distribution table and each fund's profile page after the fund's declaration date in December.

Note: Funds not listed did not expect, as of October 31, 2023, to distribute capital gains in December..
